ORDER

- 1. Whereas, the superintendence, direction and control, inter alia, of all elections to Municipal Corporation / Municipalities / Notified Areas are vested in the State Election Commission in terms of Article 243 ZA (1) read with Article 243K of the Constitution of India; and
- 2. Whereas, the word 'elections' includes the entire process of election which consists of several stages and it embraces many steps, some of which have important bearing on the process of choosing a candidate by the electorate; and
- 3. Whereas fair election contemplates disclosure by the candidate of material information relating to his/her personal background including his/her education, profession and income along with assets held by him/her, his/her liabilities to Government, Banks, Financial Institutions and local bodies, etc. which are relevant to the elector for making a choice;
- 4. Now, therefore, the West Bengal State Election Commission, in exercise of the powers, conferred on it by Article 243 ZA(1) of the Constitution of India for superintendence, direction and control, inter alia, of conduct of elections to Municipal Corporation / Municipalities / Notified Areas hereby issues directions as follows:
 - a) Every candidate at the time of filing his nomination paper seeking election to a Municipal Corporation / Municipality/ Notified Areas shall furnish full and complete information with regard to his/her personal background as mentioned at para 3 above, in the form of an affidavit, the format whereof is annexed hereto as required under Section 40 (7) of the West Bengal Municipal Election Act,1994;
 - b) The information so furnished by each candidate in the Affidavit shall be disseminated by the respective Municipal Returning Officers by displaying a copy of the Affidavit on the Notice Board of his office, office of the concerned Municipal Corporation / Municipality / Notified Areas having jurisdiction over the constituency from which the candidate is seeking election and also by making copies thereof freely available to all other candidates and representatives of the media;

- c) If rival candidates furnish information to the contrary, by means of a duly sworn affidavit, then such affidavit shall also be disseminated in the manner stated above.
- 5. All the Municipal Returning Officers shall ensure that copies of the format of the affidavit prescribed herein by the Commission is delivered to the candidates along with forms of nomination papers as part of the nomination paper. (A copy of nomination paper form, as amended, is also enclosed herewith which is to be used in the ensuing elections).
- 6. The aforesaid affidavit shall unless it is produced along with the Nomination paper be produced before the Municipal Returning Officer at the time of scrutiny.
