Whereas, a Notification under Section 8 of the West Bengal State Election Commission Act, 1994 (West Bengal Act VIII of 1994) read with Sub-Section (3) of Section 36 of the West Bengal Municipal Elections Act, 1994 (West Bengal Act XXXIV of 1994), hereinafter referred to as the said Act, has been issued by the State Government vide Notification No. 465/MA/O/C-4/1E-1/2008 (Part-I) dated 17.07.2017 fixing the 13th August, 2017, as the date of poll and 07.00 a.m. to 05.00 p.m. as the hours of poll to elect members to the Municipal Corporation / Municipalities / Notified area mentioned in the schedule below;

Now, therefore, in exercise of the power conferred by Section 37 of the said Act, the State Election Commissioner, West Bengal State Election Commission hereby appoints;

- (a) the 24th July, 2017 as the last date of making nomination;
- (b) the 25th July, 2017 for scrutiny of nominations;
- (c) the 27th July, 2017 as the last date of withdrawal of candidatures;
- (d) the 13th August, 2017 as the date on which a poll shall, if necessary, be taken from 07.00 a.m. to 05.00p.m. without interruption; and
- (e) the 21st August, 2017 as the date before which the election process shall be completed;
