Now, in exercise of the power conferred by sub-rule (1) of rule 4 of the West Bengal Municipal Elections (Reservation of Seats) Rules, 1994 (hereinafter referred to as the said rules), the West Bengal State Election Commission hereby fixes the 2<sup>nd</sup> February, 2015 to be the date for publication of the draft of the order under rule 3 of the said rules (as amended) in Form A appended to the said rules in respect of the Municipalities / Notified Areas mentioned in the schedule attached herewith (hereinafter referred to as the said Municipalities / Notified Areas).
