WEST BENGAL STATE ELECTION COMMISSION

NOTIFICATION

No. 181-SEC/1D-172/2014.—27th January, 2015.—Whereas, the State Government, in exercise of the power conferred by Section 8 of the West Bengal Municipal Act, 1993 (West Ben. Act XXII of 1993) has determined under Notification No.381/MA/O/C-4/IM-5/2004 Pt.-II dated.26.08.2014, that the number of wards in the Municipal area of the Basirhat Municipality in the district of North 24 Parganas hereinafter referred to as the said area shall be 23(twenty three).

Now, therefore, in exercise of the power conferred by Section 3 of the West Bengal Municipal Elections Act, 1994 (West Ben. Act XXXIV of 1994) and in supersession of all previous notifications in this behalf, the West Bengal State Election Commission, having regard to population, dwelling pattern, geographical conditions and economic considerations and after consideration of the views of the Municipality as aforesaid for the said area, hereby divides the said area into the required 23(twenty three) wards as described in the Table below for the purpose of election of members of the Municipality as aforesaid for the said area.
