Sir,

In continuation of this Commission's Order No.1780-SEC/1D-123/2011 dated 27.11.2012 on the subject matter stated above, I am directed to state that the following measures shall have to be taken on publication of the said Orders:-

- 1) Immediately after publication of draft orders under sub-rule(1) of rule 23 and 25 of the West Bengal Panchayat Election Rules, 2006, a copy of each of the Orders in Form 'A' & 'B' shall be supplied to each of the recognized political parties having representation in the existing body of the Gram Panchayat and Panchayat Samiti to which the order relates.
- 2) Any person affected by such order may submit any objection or suggestion in writing stating the reasons thereof <u>so</u> <u>as</u> <u>to</u> <u>reach</u> <u>the</u> <u>prescribed</u> <u>authority</u> <u>within</u> <u>15(fifteen)</u> <u>days</u> from the date of publication of the draft order as stated above.

3) The <u>prescribed authority shall consider</u> all such objections or suggestions if any, received by him within the stipulated period. All objections or suggestions shall have to be heard by giving a notice to the concerned person(s) and disposing the same by issuing a reasoned order. A copy of the reasoned order as may be passed by him, shall

also have to be communicated to the concerned person(s) forthwith keeping records

thereof. The matters should be dealt with meticulously and carefully.

4) In respect of Zilla Parishads, all objections or suggestions shall have to be addressed to the State Election Commissioner and should reach this Commission within the stipulated period. Otherwise, it may not be considered. If any objection or suggestion in this regard is received at your end, this should forthwith be communicated and sent to this

These matters should be informed accordingly to all the recognized political parties.
