**NOTIFICATION**

Whereas, a Notification under Section 8 of the West Bengal State Election Commission Act, 1994 (West Bengal Act VIII of 1994) read with Sub-Section (3) of Section 36 of the West Bengal Municipal Elections Act, 1994 (West Bengal Act XXXIV of 1994), hereinafter referred to as the said Act, has been issued by the State Government vide No. 791/MA/O/C-4/1E-1/2008 (Pt.-I) dated 27<sup>th</sup> July, 2022 fixing the 21<sup>st</sup> of August, 2022 as the date of poll and 07.00 a.m. to 05.00 p.m. as the hours of poll for Municipal Bye-Elections to elect members to the constituencies declared vacant in the Municipalities mentioned in the schedule below, for the remaining term of existing board of councillors of the said municipalities.

Now, therefore, in exercise of the power conferred by Section 37 of the said Act, the State Election Commissioner, West Bengal State Election Commission hereby appoints:

- (a) the 3<sup>rd</sup> of August, 2022 as the last date for making nominations;
- (b) the 4<sup>th</sup> of August, 2022 as the date for the scrutiny of nominations;
- (c) the 6<sup>th</sup> of August, 2022 as the last date for the withdrawal of candidatures;
- (d) the 21<sup>st</sup> of August, 2022 as the date on which a poll shall, if necessary, be taken from 07.00 a.m. to 05.00 p.m. without interruption; and
- (e) the 26<sup>th</sup> of August, 2022 as the date before which the election process shall be completed.
