
ORDER

On being satisfied that in the Municipal Elections to the six municipal constituencies, as notified vide Notification No. 1790-SEC/1E-99/2021(Pt.-I) dated 27th May, 2022, No. 1791-SEC/1E-99/2021(Pt.-I) dated 27th May, 2022 and No. 1792-SEC/1E-99/2021(Pt.-I) dated 27th May, 2022, the Counting of Votes cannot conveniently be done immediately after the close of the poll at the polling stations as provided under Section 12 of the West Bengal Municipal Elections Act, 1994 for the Constituencies mentioned in the schedule below, the West Bengal State Election Commission, in exercise of the power conferred by Article 243ZA (1) of the Constitution of India and as per proviso to Rule 41 of the West Bengal Municipalities (Conduct of Elections) Rules, 1995 (hereinafter referred to as the said Rules), hereby directs that the Municipal Returning Officers concerned shall arrange strong rooms for storing of polled EVMs and counting of votes on 29.06.2022 at a central place of the respective Municipal areas to be fixed and notified by them in terms of Rule 61B of the said Rules.


