NOTIFICATION

WHEREAS, the Municipal Returning Officer of Dhupguri Municipality has reported to this Commission under Section 61 of the West Bengal Municipal Elections Act 1994 (hereinafter referred to as the said Act) that due to natural calamity namely heavy rainfall rain and water logging, it is not possible to take poll at the following Polling Stations on 13-08-2017 and proposed for adjournment of poll;

And

WHEREAS, report of the District Magistrate & District Municipal Election Officer, Jalpaiguri has confirmed the incident and recommended for adjournment of poll;

And

WHEREAS, the Observer has also reported the same corroborating the incident;

And

WHEREAS, the West Bengal State Election Commission after taking all material circumstances into account is satisfied that poll at the following Polling Stations are needed to be declared adjourned and to appoint a date for such adjourned poll for the said Polling Stations;

Now, THEREFORE, the West Bengal State Election Commission in exercise of the power conferred by Article 243ZA of the Constitution of India read with Section 5 of the State Election Commission Act, 1994 and Section 61 of the West Bengal Municipal Elections Act 1994, declares that the poll at the following polling stations is hereby adjourned and appoints the **16th August, 2017** for taking such adjourned poll at the following polling stations between **7.00 A.M.** and **5.00 P.M.** without interruption.
