- (a) 1st Phase : from 07.05.2012 to 11.05.2012, i.e. from the last date of filing nomination papers to the last date for withdrawal of candidature.
- (b) 2nd Phase : from 31.05.2012 to 05.06.2012 till polled E.V.M.s are stored in Strong Room and the Room is properly sealed (In case of re-poll they have to remain present in the constituency on the date of re-poll also) and on the date of counting (from opening of Strong Room till declaration of results)

The Observers have been advised to contact you and the respective Municipal Returning Officer and communicate their travel plan before they actually start for their destination.

You are requested kindly to arrange for their transport, security, boarding and lodging and placing a liaison officer at their disposal during their stay in the designated area. All other facilities as may be required for proper discharge of their duties, such as a hired Mobile Phone, use of Fax Machine, Computers, Secretarial Assistance etc., may be provided.

Adequate publicity may also given so that the political parties, contesting candidates and electors may come to know the contact number of the Observer and the Guest House where the Observer will stay during his visit to the designated area so that they can contact him easily in case of necessity.
