I am directed to say that the State Election Commissioner has been pleased to decide that the employees of the Central / State Government / Local Bodies and others who may be appointed as Counting Supervisor / Counting Assistant for performing counting duty in connection with the Municipal General Elections to Durgapur Municipal Corporation, Panskura, Haldia, Dhupguri, Nalhati Municipalities and Coopers' Camp Notified Area scheduled to be held on 3<sup>rd</sup> June, 2012 shall be paid allowances as per rate detailed below:

It has also been decided that tiffin packet and /or light refreshment may be given to every personnel on duty on the day of Counting in lieu of meal charges.

It has also been decided that the Sector Staff and other Staff who will be engaged on duties other than Counting will be paid Rs.100/- on Counting day. No tiffin charge will be paid to any one for the day. The reserve Counting personnel will be paid Rs.100/- on the Counting day.
