In exercise of the power conferred by sub-section (1) of section 143 of the West Bengal Panchayat Act, 1973 (West Bengal Act XLI of 1973), read with rule 2B of the West Bengal Panchayat (Constitution) Rules, 1975 as amended up to 2012, I, the State Election Commissioner, for the purpose of reconstitution of the *Zilla Parishad* and the *Mahakuma Parishad* following the next general elections, hereby publish the draft of the order to determine for the offices of the *Sabhadhipati / Sahakari Sabhadhipati of the Zilla Parishad* and the *Mahakuma Parishad* within the State, as specified in column(1) of the Schedule below, the total number of offices in the State specified in the corresponding entries in column(2) of the said Schedule, the number of offices in the State reserved for the Scheduled Tribes, the Scheduled Castes, the Backward Classes and Women members specified in the corresponding entries in columns(3a), (3b), (3c) and (3d) respectively of the said Schedule, the offices reserved for the Scheduled Tribes or the Scheduled Castes or the Backward Classes specified in the corresponding entries in column (4), and the offices reserved for women specified in the corresponding entries in column(5), of the said schedule, for information of persons likely to be affected thereby.

The draft will be taken into consideration after two weeks from this day and any objection or suggestion with respect thereto which may be received by the undersigned before that date shall be duly considered.
