ORDER

In exercise of the power conferred by Section 140 of the West Bengal Panchayat Act, 1973 (as amended up to 2012) read with Sections 16 of the West Bengal Panchayat Elections Act, 2003 and Section 17 of the West Bengal Panchayat Elections Act, 2003 (as amended up to 2012) read with rule 26 of the West Bengal Panchayat Elections Rules, 2006 (as Amended vide No.4 5013/PN/O/3R-1/2012 dated 24-09-2012 of P&RD Deptt., Govt. of West Bengal) and rule 27 of the West Bengal Panchayat Elections Rules, 2006, West Bengal State Election Commission, hereby determine after previous publication of the draft of this Order as required under the said rules for the Block specified in column (1) of the Schedule below (hereinafter referred to as the said Schedule), the number of members to be elected to the Zilla Parishad specified in the corresponding entries in column (2), to divide the area of the Block into constituencies specified in the corresponding entries in column (3), to determine the constituency or constituencies reserved for the Scheduled Tribes(ST), Scheduled Castes (SC) or the Backward Classes (BC) specified in the corresponding entries in column (4) and the constituency or constituencies reserved for women specified in the corresponding entries in column (5) of the said schedule.
