Sub: Publication of list of Polling Stations in connection with Municipal Bye-Elections scheduled to held in November, 2013

Sir,

In terms of the provision of Sec.12 of the West Bengal Municipal Elections Act, 1994, the West Bengal State Election Commission issues hereby the directions and guidelines for publication of list of polling station in connection with the Municipal By-Elections (a detailed list of Municipal Constituencies (Wards) where such By-Elections to be held is enclosed herewith) referred in the subject quoted above as follows:

- 1. The list of Polling Stations was finalised, following this Commission's direction, during last general elections to the Municipal Corporation / Municipalities where Bye-Elections are now going to be held to fill up the casual vacancies. In case no change or modification in the finalised list of Polling Stations is considered necessary, then the Municipal Returning Officer shall publish the list of Polling Stations of the ward /wards of the Municipal Corporation / Municipality in the prescribed Format (enclosed herewith) by displaying a copy of the list of Polling Stations at his office, office of the District Municipal Election Officer, office of the Municipal Bodies concerned and at least in one place within the area of the ward concerned where local people usually visit. Such list shall be published not later than the 9th October, 2013.
- 2. In case of any change or modification is considered necessary a meeting with the representatives of local units of recognised political parties shall be convened and after consulting them the list of polling stations shall be finalised. Where a modification is considered necessary from the point of view of Municipal Returning Officer but not acceptable to any political party full justification should be recorded in writing and the modified list of polling stations shall be published in the manner as indicated above. Such list shall finally be published not later than 31st October, 2013 in the usual format.

- 3. Polling Stations should be situated within the Ward so that, no voter is required to go outside his constituency to caste his/her vote and number of voters in a Polling Station should ordinarily not exceed 1200.
- 4. Each contesting candidate shall be supplied free of cost, with three copies and each recognised political party with two copies of the list of polling stations immediately after the publication of the list of polling stations.
- 5. The commission may be kept informed of the action taken along with a copy of the list of polling stations.
- 6. Municipal Returning Officer concerned may please be instructed accordingly. Copies of this memorandum are also endorsed to them.
- 7. This order issues in partial modification of this Commission's Order No.3215(12)-SEC/5P-16/2013 dated.05.08.2013.
