2. You are hereby authorized to make appropriate sub-allotment in favour of the Municipal Returning Officer & Sub-Divisional Officer concerned for drawal and disbursement of the grant as and when considered necessary. Necessary bill for this grant will be drawn in grant-in-aid bill form (T.R. Form No. 31) of the West Bengal Treasury Rules, 2005.

3. You are requested to submit the utilization certificate in respect of the aforesaid grant in terms of S.R. 330A of the Treasury Rules, West Bengal Vol-I to the Principal Accountant General (A&E), West Bengal with a copy to West Bengal State Election Commission and Municipal Affairs Department, Govt. of West Bengal in due course **along with the statement of item-wise expenditure.**

4. While incurring expenditure you should ensure that:

- a) **No vehicle will be repaired from this fund released for this purpose.**
- b) **No furniture, duplicating machines, photocopier, computer etc. will be purchased from this fund.**
- c) **The expenditure should be incurred judiciously, cautiously and only for the election related work.**
- d) **Separate register should be maintained by the D.D.O./s for the expenditure incurred in connection with the aforesaid elections.**

5. The charge will proceed against the head "2217-Urban Development-05-Other Urban Development Schemes-192-Assistance to Municipalities / Municipal Councils-NP-Non Plan-003-Grants to Municipalities in connection with their election-V-Voted-31-Grants-in-aid-GENERAL-02-Other Grants" out of the current year's budget grants i.e. 2013-2014 under Demand No.39 with the Departmental Code "MA".

6. The sub-allotment is released out of the fund received from the Municipal Affairs Department, Govt. of West Bengal vide it's No. 189(sanction)/MA/N/C-4/1E-1/2006 Dated Kolkata the 10th September, 2013 and No. 249(sanction)/MA/N/C-4/1E-1/2006 Dated Kolkata the 21st October, 2013.
