Again C.E.S.C. Ltd. may be advised for supply of uninterrupted power to State Election Commission's office at 18, Sarojini Naidu Sarani, Kolkata-17 from the forenoon of 22nd November, 2013 to 25th November, 2013 in the interest of smooth conduct of such elections.
