ORDER

In pursuance of section 46 of the West Bengal Municipal Election Act, 1994 as amended and sub-rules (1) and (2) of rule 9 of the West Bengal Municipalities (Conduct of Elections) Rules, 1995, the West Bengal State Election Commission hereby directs that at the municipal election in a municipal constituency, the list of contesting candidates shall be prepared in Form 7 in Bengali and English languages. The particulars in Bengali should appear first over those in English. Though the list is prepared in more than one language the names of candidates shall be classified as (i) candidates of recognized political parties (ii) candidates of registered political parties other than those mentioned in clause (i) and (iii) other candidates. The names of candidates in each category shall be arranged in alphabetical order (following Bengali alphabet) and the addresses of the contesting candidates as given in the nomination papers together with such other particulars if any. The serial no. of candidates of all three categories shall be given consecutively and not separately for each category.

A copy of the list of contesting candidates in Form 7 for every constituency should be forwarded to this Commission by special messenger immediately after its preparation.
