## **ORDER**

Now, THEREFORE, in pursuance of the provision of section 91 of the said Act, the Governor, in consultation with the West Bengal State Election Commission, is pleased hereby to direct that the provisions of sections 160 and 161 of the Representation of the People Act, 1951 (43 of 1951) shall be followed for the purposes of requisitioning of premises and vehicles and payment of compensation there for in connection with the elections to the Municipalities in West Bengal.
