**Sub.: Metal seals of Presiding and Municipal Returning Officers.**

Madam / Sir,

I am directed to state that the design of the metal seal of Presiding Officer and Municipal Returning Officer (MRO) will be as follows:

(a) For Presiding Officer -

(b) For Municipal Returning Officer -

First, there should be three capital letters in the Roman Script to represent the abbreviated form of Municipal Returning Officer. Below these letters there should be a straight line. Under that straight line there should be three capital letters also in the Roman Script to represent the abbreviated form of the Municipality as authorized by this Commission (the authorized abbreviation for the Haldia Municipality is HLD). For example for the Municipal Returning Officer, Haldia Municipality the MRO's seal will be -

**MRO**  
**HLD**

Separate order showing abbreviated form of the Municipal body where election is being held on 22<sup>nd</sup> November, 2013, has already been issued under this Commission's No.3921-SEC/8C-1/95(Pt.-I) dated.23.10.2013.


