O R D E R

WHEREAS an order was issued by the W.B. State Election Commission vide No. 347-SEC/3E-24/2012 dated 18.02.2015, in exercise of power conferred by proviso to sub-Section (1) of Section 5 of the West Bengal State Election Commission Act, 1994 read with Section 16(A) of the West Bengal Municipal Election Act, 1994, for adoption of the relevant parts of the Electoral Rolls for Assembly Constituencies published by the Election Commission of India with reference to the 1st day of January, 2015 including supplement thereto which was in force on the date of the aforesaid order as Municipal Electoral Rolls for the Municipal General Elections, 2015; AND

WHEREAS it has come to the notice of this Commission that names of some electors including persons intending to contest in the ensuing Municipal General Elections, 2015 have been enrolled by way of Continuous Updation of Assembly Electoral Rolls by the respective Electoral Registration Officers subsequent to the last final publication of Assembly Electoral Rolls with 01.01.2015 as the qualifying date ; AND

WHEREAS this Commission considers that such persons who have been registered as electors of respective Assembly Constituencies subsequent to the last final publications of the said rolls under the Continuous Updation Scheme by the respective Electoral Registration Officer upto 09.03.2015, the date of publication of Adopted Municipal Electoral Rolls, should be treated as electors for the ensuing Municipal General Elections, 2015 ;

Now, therefore, in exercise of the power conferred by the Proviso to sub-Section (1) of Section 5 of the West Bengal State Election Commission Act, 1994, it is hereby ordered that the persons whose names were not included as electors in the finally published Electoral Rolls of Assembly Constituencies with 01.01.2015 as the qualifying date, but who have subsequently been registered as electors and assigned part Nos. and Sl. Nos. in the relevant Assembly Electoral Rolls upto 09.03.2015, should be included as electors in the Municipal Electoral Rolls for the ensuing Municipal General Elections, 2015. A supplement of such electors shall be prepared and published by the Municipal Electoral Registration Officers concerned within the last date of filing nominations for the concerned Municipal Bodies and the same shall be appended to the Municipal Electoral Rolls already published according to the aforesaid order.

It is further ordered that in cases of Assembly Electoral Roll Parts not conforming to the jurisdiction of the concerned Municipal Constituencies (Wards), the Municipal Electoral Rolls shall be suitably amended by way of transposition of the concerned electors to the relevant part of the Municipal Electoral Rolls, if not already effected in the Municipal Electoral Rolls published on 09.03.2015.


