NOTIFICATION

WHEREAS, the District Panchayat Election Officer & District Magistrate, Cooch Behar has reported in terms of sub-section (2) of Section 67 of the West Bengal Panchayat Elections Act, 2003 (herein after referred to as the said Acts) that poll at the polling stations as mentioned in column (1) of the Table below (herein after referred to as the said Table) has been declared void in respect of constituencies under the Block mentioned in Column (2) against polling station no. of the said Table, in terms of sub-section (1) of Section 67 of the said Act;

NOW, THEREFORE, the West Bengal State Election Commission, in exercise of the powers conferred on it by sub-section (3) of Section 67 of the said Act, hereby fixes **27th day of July, 2013** as the date of taking of fresh poll at 07.00 hours to be continued upto 17.00 hours uninterruptedly till completion and direct the District Panchayat Election Officer to fix the polling station at which poll shall be taken.




