- 2. The Labour Department will issue suitable instruction to shops, commercial and industrial Establishments to declare the said date as paid holiday for the workers who are voters for the said election.
- 3. If the date of poll is a working day in any central Government or any other establishments within the concerned Municipal areas, the employees who are voters to the election shall be permitted to cast their votes by way of special leave.

- 4. In case of an employee working outside the concerned Municipal areas and who is a voter to the said elections shall be allowed special leave to exercise the franchise.
- 5. The day before the date of poll being the date of dispatch is hereby declared as local holiday for the educational institutions situated within the respective Municipality areas as stated in Para 1 above.
- 6. In case of re-poll, the employees/workers shall be allowed to cast their vote on the date of re-poll by way of late arrival or early departure.
- 7. In case any educational institution or any other establishments has been selected as dispatch centre outside the Municipality area, local holiday on the day of dispatch may be declared for the said institution by the competent Authority.
