ORDER

NOW, THEREFORE, in exercise of the power conferred by the proviso to sub-section (1) of Section 5 of the West Bengal State Election Commission Act, 1994 (West Bengal Act VIII of 1994), read with Section 16A of the West Bengal Municipal Elections Act, 1994, the State Election Commissioner, West Bengal State Election Commission, hereby orders that the relevant parts of the electoral rolls published by the Election Commission of India with reference to the 1st day of January, 2015, including supplements thereto which are in force on the date of this order for election of members to the West Bengal Legislative Assembly, shall be adopted as the electoral roll (hereinafter referred to as the municipal electoral roll) for the purpose of holding Municipal General Election (hereinafter referred to as the said election) in each of the constituencies of the said Municipal Corporation / Municipalities and that the Municipal Electoral Registration Officers concerned shall sub-divide the Municipal Electoral Roll, in such manner or in such part or parts as he / she may deem expedient for use in respect of each of the Municipal Corporation / Municipalities for the purpose of the said election and shall cause display of the said municipal electoral roll for each of such constituencies on the 9th March, 2015 at —

- a) his / her office.
- b) the office of the District Magistrate & District Municipal Election Officer,
- c) the office or offices of the Municipal Corporation / Municipality / Notified Area,
- d) such other places in the municipal area as he / she thinks fit.
