ORDER

I have gone through the letter no. 172/DPO/XIX(S)/2/2012 dated 12.02.2013 of the District Magistrate, North 24 Parganas.

2. The number of offices of Upa-Pradhan to be reserved for Scheduled Caste category as determined under clause(a) of sub-rule (1) of rule 2A of the West Bengal Panchayat (Constitution) Rules, 1975 is 61. Out of 200 Gram Panchayats in the District of North 24 Parganas, the offices of the Pradhan have been reserved for Scheduled Castes, Scheduled Tribes, Backward Classes, Scheduled Caste Women, Scheduled Tribe Women, Backward Classes Women and Women in general category in 150 Gram Panchayats. There are 50 number of offices of Gram Panchayats available for reservation of Upa-Pradhan after exclusion of the grams where offices of the Pradhan have been reserved for the 1st term of election.

3. Out of 50 Gram Panchayats which are available for reservation of the offices of Upa-Pradhan, 8 number of offices of Upa-Pradhans have been reserved for Scheduled Tribes and 60 Gram Panchayats are required to be reserved for SC. But only 40 Gram Panchayats out of 42 have more than 5% of the total population in the district of North 24 Parganas and the offices of Upa-Pradhans have also been reserved for Scheduled Castes in those 40 Gram Panchayats accordingly. The remaining two Gram Panchayats where SC population is less than 5% (i.e. 4.22 and 2.69) namely Amdanga Gram Panchayat under Amdanga Block, and Dadpur Gram Panchayat under Barasat-II Block respectively two seats / constituencies are available for the said category where reservation of offices can be made for SC Women category in pursuance of Rule 2A(2)(vii) of the West Bengal Panchayat (Constitution) Rules, 1975.

4. In the above circumstances, in exercise of the powers conferred by Section 4(1) of the West Bengal State Election Commission Act, 1994 read with rule 2A(2)(vii) of the West Bengal Panchayat(Constitution) Rules, 1975, I hereby order that the office of the Upa-Pradhan of Amdanga Gram Panchayat under Amdanga Block and Dadpur Gram Panchayat under Barasat-II Block shall be reserved for the Scheduled Caste (Women) for the 1st term of election to be held in 2013.

This disposes of the memo 172/DPO/XIX(S)/2/2012 dated 12.02.2013 of the District Magistrate, North 24 Parganas.

This order may be communicated to the District Magistrate & District Panchayat Election Officer concerned for taking further course of action.
