**NOTICE INVITING QUOTATION**



5. Bidders will be responsible for providing services of the items within 24 (twenty four) hours, when called for.

7. The Companies / supply agencies must mention the warranty period for the product.
8. Bidders must submit their PAN & Trade License / Authorization for his company as agency etc. The bidder should be presently supplying hardware/ software or similar items in any Central or State Govt. Dept., PSUs or Autonomous Bodies.
