NOTIFICATION

In exercise of the power conferred by sub-clause (VI) of clause (9) of section 86 of the Bengal Excise Act, 1909 (Ben. Act V of 1909) as delegated to the Excise Commissioner, West Bengal by sub-paragraph (3) of paragraph 14 of the consolidated orders made under the provisions of the Act and published through Notification No. 596-SR dated 30th March, 1915 as amended up-to-date, the Excise Commissioner, West Bengal do hereby make the following Rules with immediate effect in supersession of the Rules published through Notification No. 85-EXC dated 24th January, 1989 as amended subsequently through Notification No. 03-EXC dated the 2nd July, 1998:—

Rules

1. These Rules shall be called the West Bengal Excise (Closure of Retail Excise Licensed Premises on special occasions viz. election) Rules, 1998.
2. Notwithstanding anything contained elsewhere these rules shall take immediate effect.
3. Notwithstanding anything contained in any other Rules or Notifications—the retail licensed premises for the sale of country spirit, coloured/flavoured spirit, pakhni, tari, 50° UP-rum, beer, bhang, foreign liquor through OIF shops, foreign liquor through On shops and foreign liquor through bars attached to hotels, restaurants, motels, pubs, clubs, cinema halls, tourist lodges, any other places of public resort or entertainment, dak-hungalows, railway refreshment rooms, dining cars and steamers shall be kept closed as detailed in the table below:

TABLE

Occasion	Day(s) of closure
1. General or Bye-election to the Lok Sabha or Vidhan Sabha	During the period of forty-eight (48) hours ending with the hour fixed for conclusion of the poll within the territorial jurisdiction of the concerned constituency(ies) where poll(s) are held.

2. Election or bye election to the Municipality or Panchayat or Municipal Corporation.

Day(s) of closure

On the day(s) of the Poll and on the day immediately preceding the day of the poll within the territorial jurisdiction of the concerned constituency(ies) where poll(s) are held.
