School and college premises within the concerned Municipal areas will also be required to be used for polling purposes. Besides the services of non-teaching employees of educational institutions may be required for the aforementioned election work.


I am, therefore, directed to request you kindly to issue necessary instructions so that –

- iii) furniture in these premises as may be required, with the facility of power, drinking water supply, toilets and use of public convenience, may be made available in the said premises in connection with these elections.


