**ORDER**

It has already been ordered vide Order No.3962-SEC/1M-20/2013 dated 25.10.2013, that there should be no hoardings, posters, banners wall-writings etc. of political parties canvassing or soliciting votes in favour of candidates set up by these parties, within 100 meters of any polling station.

It is therefore essential that before the day of poll such hoardings, posters, banners, wall-writings etc should be removed/obliterated from the area falling within 100 meters of such polling premises.

In order to do that it has been decided that this work should be done by the Municipal Returning Officers concerned with the help of the local Police Stations.

It has also been decided that in order to do this the Municipal Returning Officers are authorized to incur expenditure at the rate not exceeding Rs. 500/- (Rupees five hundred) only per polling premises if necessary from the election contingency fund at their disposal. The District Municipal Election Officer will place requisite fund at the disposal of concerned Municipal Returning Officers for this purpose. Municipal Returning Officers may please be suitably advised.
